CBHS Member – Fitness Passport Subsidy February 2025

Full Terms and Conditions

Definitions

CBA means Commonwealth Bank of Australia (ABN 48 123 123 124) including a wholly owned CBA entity.

CBHS means CBHS Health Fund Limited (ABN 87 087 648 717).

Fitness Passport Membership means a membership issued by Fitness Passport Pty Ltd (ACN 118 246 029) to provide access to participating gyms, swimming pools and/or leisure facilities.

Participant means:

- A current permanent, casual or fixed term employee of CBA who must reside in Australia and hold an active Fitness Passport Membership; and
- A current, active CBHS member (premiums paid up to date and policy not suspended for travel or financial hardship reasons); and
- Holds hospital cover, or combined hospital and extras cover, or packaged hospital and extras cover issued by CBHS and determined from time to time.

Subsidy means \$11.50 per week (incl. GST).

- Information on how to receive the Subsidy forms part of these terms and conditions.
- 2. Fitness Passport Membership is offered as a CBA employee benefit.
- A Subsidy is only available to current CBA employees who hold a Fitness Passport Membership, are active members of CBHS and hold an eligible CBHS Hospital product.
- 4. Prices differ based on state and Fitness Passport class of member and package chosen.
- 5. Fitness Passport Membership will be activated and cancelled as determined by Fitness Passport.
- Participant must immediately notify Fitness Passport by emailing info@fitnesspassport.com.au if they no

- longer meet the definition of a Participant.
- 7. If an individual does not meet the definition of a Participant, they will immediately cease being eligible to receive the Subsidy.
- 8. The Subsidy is only available on one Fitness Passport Membership at any one time.
- Participant acknowledges that the Subsidy is non-refundable, not exchangeable or transferable and cannot be redeemed for cash.
- 10. CBHS reserves the right to amend these terms and conditions including the definition of Participant and/or vary the amount of the Subsidy in its absolute discretion. A Participant will not be entitled to receive any compensation or set off in the event that the Subsidy is not available.
- 11. CBHS (including its officers, employees and agents) excludes all liability including negligence (except for liability that cannot be excluded by law, in which case liability is limited to the minimum permitted by law) for any personal injury, death, loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising out of use of the Fitness Passport Membership.
- 12. Participants agree to indemnify CBHS against all losses, liability, actions, claims, costs, expenses and demands sustained, incurred or suffered, to the extent arising out of or in connection with Participant's use of the Fitness Partnership Membership.
- 13. Fitness Passport Membership is subject to the Fitness Passport <u>Terms</u> and Conditions.
- 14. CBHS will use and handle personal information as set out in the <u>Privacy</u> Policy.
